Distribution shares (1)	Distributing shares that pay out dividends, if any, on a regular basis.
Accumulation shares (2)	Non-distributing shares that do not pay out dividends or interest. Any dividends arising from the underlying securities are retained in the fund.

The minimum subscription amount in each fund is US\$ 2,500 or the equivalent in the payment currency. The minimum subsequent subscription amount for each fund is US\$ 500 or the equivalent in the payment currency.

### Unhedged Share Classes
