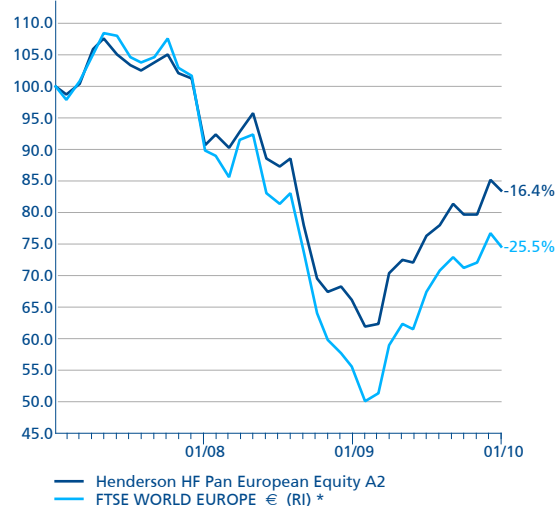

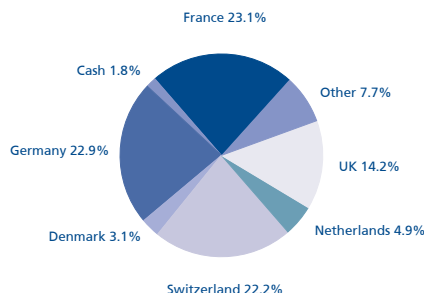

Average Annual Total Return to 31 January 2010

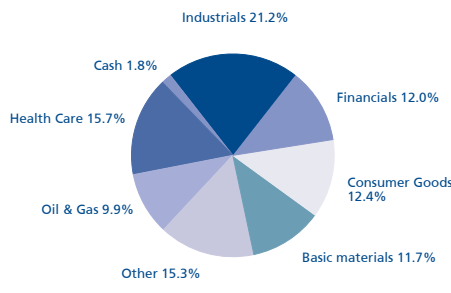
