## Objectives and investment policy

### Objective

A combination of income and growth in excess of typical returns in Continental European equity markets over the long term.

### Investment policy

Under normal circumstances, the Fund invests mainly in:

- Shares of companies in Continental Europe in any industry

The Fund may also invest in:

- Any other type of security that is consistent with its objective
- Money market instruments
- Bank deposits

In choosing investments, the investment manager looks for stocks that appear to have the potential to rise in price over the long term and that are undervalued.

The Fund may use investment techniques for efficient portfolio management or to manage risks.

**Designed for** Investors who understand the Fund's risks, want a European-focused investment, and intend to invest their money for at least seven years.

**Fund currency** EUR

**Share class currency** EUR

### Terms to understand

**Money market instruments** Liquid investments that pay interest and are designed to maintain a stable value.

**Shares** Securities that represent fractional ownership in a company.

**Volatility** How sharply the Fund's share price has gone up and down over a period, generally several years.

You can buy, sell or switch shares in the Fund on any business day, as defined within the "Glossary" Section, of the Fund's prospectus.

*The Fund offers accumulation shares (shares in which net income is retained within the price).*

## Risk and reward profile



The value of an investment in the Fund can go up or down. When you sell your shares they may be worth less than you paid for them.

The risk/reward rating above is based on medium-term volatility. In the future, the Fund's actual volatility could be higher or lower and its rated risk/reward level could change.

The Fund's risk level reflects the following:

- The Fund focuses on a single region
- As a category, shares are more volatile than either bonds or money market instruments
- Fluctuations in exchange rates may cause the value of your investment to rise or fall

The rating does not reflect the possible effects of unusual market conditions or large unpredictable events which could amplify everyday risk and trigger other risks such as:

**Counterparty risk** The Fund could lose money if an entity with which it interacts becomes unwilling or unable to meet its obligations to the Fund.

**Liquidity risk** Certain securities could become hard to value or sell at a desired time and price.

**Management risk** Investment management techniques that have worked well in normal market conditions could prove ineffective or detrimental at other times.

## Charges

The charges you pay are used to pay the costs of running the Fund, including the costs of managing and distributing it. These charges reduce the potential growth of your investment.


